# Privacy Notice for the Processing of Personal Data in relation to the Liquidation of PROMETHEUS INSURANCE COMPANY LIMITED.

- 1. Under the Motor Vehicles (Third Party Insurance) Law 96 (I) / 2000, as amended ("Motor Vehicles Law") and other EU and National Directives and Regulations as well as International Conventions, the Motor Insurers' Fund (the "Fund") has a legal obligation in certain occasions to compensate individuals who have suffered vehicle or other property damage, personal injuries and death as a consequence of a road traffic accident with drivers insured with insurance companies under liquidation.
- 2. As a result of a judgment dated 27 January 2021 an Order was issued by the Supreme Court of Gibraltar, Frederick David John White (referred to as the "Administrator") was appointed as Administrator of PROMETHEUS INSURANCE COMPANY LIMITED ("PROMETHEUS").
- 3. In view of the above, the Fund and the Administrator (collectively referred to as "Data Controllers") are responsible for the collection and processing of your personal data in the event you submitted a claim which concerns a vehicle that was insured with PROMETHEUS.

### 4. Why do the Data Controllers process personal data?

- i. Compliance with legal obligations and Court orders: To comply with the Order dated 30 July 2019, the Motor Vehicles Law and other EU and National Directives and Regulations as well as International Conventions;
- **ii.** Safeguarding the legitimate interests of the Data Controllers and claimants: The processing of personal data may be necessary for the purposes of safeguarding the legitimate interests of the Data Controllers and claimants such as the examination and settlement of claims.
- **iii. Legal Claims:** For establishing, exercising or defending legal claims in Court proceedings and out-of-court procedures.
- **iv.** The public interest: The Data Controllers ensure that proper and just compensation is provided to individuals involved in road traffic accidents irrespective of the insurance status of the individual who caused the road traffic accident or the fact that PROMETHEUS is under liquidation.
- v. Consent: In case you have provided your consent to the collection and processing of personal data, you may withdraw your consent at any time by contacting us at 23 Zenonos Sozou, 2nd floor, Nicosia 1075, or by email at dpo@mif.org.cy.

## 5. What kind of personal data categories do the Data Controllers process?

The Data Controllers may collect and process personal data of persons involved in a claim that concerns a vehicle that was insured with PROMETHEUS. The Data Controllers will process only the necessary personal data categories required for the examination and settlement of claims which include the following:

- General identification and contact information (e.g. full name, address, telephone number).
- Details of insurance policy (e.g. insurance policy number, etc).
- **Details of vehicle and/or vehicles involved and/or drivers involved** (e.g. license plates, name and surname of the owner, name and surname of the driver etc).
- **Health related data** (e.g. personal injury, medical reports).
- Details of the accident (e.g. date of the accident, location of the accident etc).
- Details and particulars of damages (e.g. vehicle, property).

## 6. Who are the potential recipients of your personal data?

Your personal data may be processed by external associates of the Data Controllers such as lawyers, IT Providers, doctors, agents, advisors and external service providers. Furthermore, the Data Controllers may transfer your personal data to third countries which do not provide an adequate level of personal data protection. The Data Controllers will ensure that personal data transferred and processed by third parties are adequately protected.

# 7. Which are the sources of personal data collection?

The personal data collected and processed by the Data Controllers are collected from claimants, government authorities and independent service providers of the Data Controllers.

#### 8. How long do the Data Controllers keep personal data?

Generally, the Data Controllers will keep personal data for the time period required to examine and settle a claim.

## 9. What are my rights in relation to the processing of my personal data by the Data Controllers?

In some instances, you may have the right to request a copy of the categories of your personal data kept by the Data Controllers, request the correction or deletion of your personal data, object to, or request the restriction of processing of your personal data. Furthermore, you may additionally withdraw your consent in cases where the processing is based on your consent and file a complaint to the Office of the Commissioner for Data Protection.
