

# **CONSENT FOR THE PROCESSING OF PERSONAL DATA**

## **Introduction – Data Controllers**

The Motor Insurers' Fund (the "Fund") has a legal obligation in certain occasions to compensate individuals who have suffered vehicle or other property damage, personal injuries and death, as a consequence of a road traffic accident with drivers insured with insurance companies under liquidation.

As a result of a judgment dated 27<sup>th</sup> January 2021 an Order was issued by the Supreme Court of Gibraltar, Frederick David John White (referred to as the "Administrator") was appointed as the Administrator of PROMETHEUS INSURANCE COMPANY LIMITED ("PROMETHEUS").

In view of the above, the Fund and the Administrator (collectively referred to as "Data Controllers") are responsible for the collection and processing of your personal data in the event you submitted a claim which concerns a vehicle that was insured with PROMETHEUS.

## **Purpose of collection and processing**

The Data Controllers, their agents and advisors, in the context of examining your claim, intend to collect and process categories of personal data which concern you or concern children on behalf of which you consent as a legal guardian. Please note that the collection and processing of certain categories of personal data is necessary for the examination of claims. In case you do not provide your consent, we may not be able to examine and satisfy your claim.

## **Privacy Notice for the Processing of Personal Data in relation to the Liquidation of PROMETHEUS**

When the Data Controllers collect and process personal data, they ensure that this is carried out lawfully and that all the necessary measures are taken to ensure their safety. Please read carefully the *Privacy Notice for the Processing of Personal Data in relation to the Liquidation of PROMETHEUS INSURANCE COMPANY LIMITED*, which is attached to this consent form and is also available at [www.mif.org.cy](http://www.mif.org.cy), which contains further information on the processing of personal data that is carried out.

## **Categories of Personal Data**

The Data Controllers will collect and process the following categories of personal data where this is required for claim examination purposes:

- **General identification and contact information of claimants** (e.g. full name, address, telephone number).
- **Details of the claimant's insurance policy** (e.g. insurance policy number, etc).
- **Details of the claimant's vehicle and/or vehicles involved and/or drivers involved** (e.g. license plates, name and surname of the owner, name and surname of the driver etc).
- **Health related data of the claimant** (e.g. personal injury, medical reports).
- **Details of the accident** (e.g. date of the accident, location of the accident etc).
- **Details and particulars of damages** (e.g. vehicle, property).

## **Withdrawal of your consent**
